Rules & Rental Agreement

No refunds, no babies, no animals including service dogs, no beaching and/or shore contact of rental allowed.

If you are changing passengers, it must be done at our dock.

Maximum of two (2) vehicles per boat rental allowed in our parking lot.

Anyone age 12 & under must wear a life jacket before entering dock & at all times while the boat is underway.

We supply life preservers for each person in your party-infants must be walking and at least 30 lbs.

Driver's license and a refundable deposit of \$40 required.

One hour minimum charge on any rental/unreturned rental tickets will be charged full day rates.

Boats not returned to the dock by 5pm will be charged a \$40 late fee (forfeit of deposit).

A valid Arizona fishing license is required for resident and nonresident anglers 10 years of age or older fishing in Lynx Lake. Swimming, by people or pets, is not allowed in Lynx Lake.

Electric row boat rentals-if your motor seems slow, please check blades for obstructions (weeds, fishing line...)

Always ensure motor is completely off before checking/lifting it out of water. Please don't litter – pack it in, pack it out.

If you breakdown or turn your boat over, stay with the boat until rescued-it floats.

Renter agrees to pay 3 Ducks LLC for any and all expenses incurred to recover, restore and/or replace any boat and equipment due to such carelessness and/or failure to return, theft and/or loss. This agreement expires once boat and equipment are returned and checked in at the dock, and rental ticket is returned to the store. In the state of Arizona, a person commits the crime of theft by knowingly, and without lawful authority to do so, taking any of the following actions: controlling another person's property with the intent to deprive them of the property, using another person's property or services for an unauthorized period of time, obtaining another person's property and services through material misrepresentation (i.e. fraud), controlling lost property without reasonably attempting to find its owner, and/or controlling stolen property. **We prosecute.**
